- Expense/income report
  - 2 Prent shows made approximately \$4,800
- Started year at \$83k, will end year around \$65,000
- Budget vote for 21-22
  - Voted to increase scholarship amount by \$3,700 and to pay at the end of year versus beginning
  - Voted to reimburse the theatre department \$5,000 toward lights
  - Jamie Olson first motion, Jodie Flint second motion, motion carried
- 2022/2023
  - Costs have gone up in recent years, but we have kept prices flat
  - In the past, the students' banquet tickets were comped. Recommend going to \$50/ticket going forward.

- o Recommend increasing production fee \$100 per student
- o Recommend eliminating Drama Daze to focus on middle school with a \$10,000 fundraising goal.
- o Recommend raising fee for Musical to \$100 to offset rising costs for sound and other costs
